
The Dean (Quality) presented a detailed report on achievements of KLEF in terms of various rankings. The following are the achievements listed in the meeting.

Both the external members, Dr. V. Venkaiah and Dr. P. Thrimurthy, have expressed their happiness at KLEF achieving such good rankings in NIRF 2022 and other Rankings. They appreciated the Gap analysis done by IQAC and mentioned that it is very hard to improve upon some of the sub-metrics. Dr. Venkaiah suggested that continuous efforts are required to improve public perception.

Reporting Item 2: Discontinuation of ODL courses

It is a known fact that OL is more flexible and versatile than ODL Courses and hence, students are now-a-days opting for OL rather than ODL Courses. In view of this, the Board of Management (BOM) of KLEF, in its meeting held on 30 June 2022, resolved to discontinue ODL Programs with immediate effect @KLEF CDOE. A letter has been written to the UGC in this regard on 3rd September 2022. However, the already admitted students will get all the support to complete their degrees in due course of time. KLEF CDOE shall continue to offer OL Programs.

Dr. Venkaiah highlighted the difficulties of scoring 10% marks allotted to OL/ODL under 'Dual' Mode University Category and appreciated the decision of the BOM-KLEF to discontinue with the ODL Courses from the current academic year.

Dr B. Sekhar Babu, Dy. Registrar, KLEF informed the members that there has been a good response (over 500 enquiries) for joining Dual Degree Courses (Student studying One Program in regular mode and studying another Program in online mode). The Dean-Quality mentioned that there has been great demand; over 10000 students joined for B. Sc. (Computer Science) OL program offered by IIT Madras, Chennai alongside their regular courses.

Reporting Item 3: Orientation programme by IQAC to Faculty

The Dean, Quality informed the committee that IQAC is regularly conducting Orientation programmes to KLEF Faculty of both Vijayawada Main campus and Hyderabad off-campus. Dr. K. Ramakrishna, Dean-Quality conducted Orientation Program to around 150 faculty members of KLEF Vijayawada Campus on Quality Parameters (TLP & Research) on 14-09-2022. Dr. K. Ramakrishna, Dean-Quality conducted Orientation Program to faculty members of KL Hyderabad Campus on Quality Parameters (TLP & Research) during 20-21 September 2022.

Reporting Item 4: Observing Vigilance Awareness Week

KLEF has been observing Vigilance Awareness Week since 2016. As per the Circular issued by the Central vigilance Commission (CVC) on 25 July 2022, the Vigilance Awareness Week shall be observed from 31st October 2022 to 6th November 2022. Newly joined faculty shall be taking Oath against corruptive practices as directed by the CVC. 31st October 2022 happens to be the birthday of first Dy. Prime Minister of India, Bharat Ratna, Sardar Vallabh Bhai Patel.

Reporting Item 5: ISO 21001:2018 First Surveillance Audit

ISO 21001:2018 First Surveillance audit is due on 02/11/2022. KLEF is not continuing with BMQR – as it is not 'NABCB' or 'IAF' Certified Agency. KLEF requested few new Agencies to provide professional charges for the following ISO-related services:

- ISO Certification for the entire University having 27 Departments.
- ISO Certification charges, Dept-wise [for certain identified Depts; at a time, we will go for Minimum 10 Depts].
- Training and certification support of ISO Lead Auditor for 2 No. of our senior faculty.

Dr. V. Venkaiah suggested that instead of 2 faculty, 5 Faculty members from IQAC may be trained as ISO Lead auditors, who in turn could train other faculty members.

Reporting Item 6: World Quality Day Celebrations

KLEF has been celebrating World Quality Day since 2016. The theme of CQI 2022 World Quality Week (7-11 November 2022) is:" Quality **conscience: Doing the right thing**". IQAC-KLEF shall be celebrating the World Quality Day on 10 November 2022 (second Thursday in the month of November) with the following events:

Dr. V. Venkaiah suggested that a greater number of students shall be involved in the World Quality Day celebrations to bring quality awareness among them.

Reporting Item 7: Forthcoming IQAC One-day Workshop on OBE

Dr. K. Ramakrishna, Dean-Quality informed the members that IQAC is planning to conduct a One Day National Workshop on "Imparting Quality in Teaching & Learning through Outcome Based Education" in association with the Academic Staff College (ASC). Shree Velagapudi Ramakrishna Memorial College, Nagaram, who benefited from IQAC-KLEF in the past NAAC Accreditation, have also expressed their desire for collaborating with this event.

Dr. Arshad Noor Siddiquee, Professor of ECE, Jamia Millia Islamia (A Central University), New Delhi shall be delivering the classroom sessions on OBE. Dr. K. Ramakrishna (Dean-Quality), Dr. V. R. Raghuveer (Dean-Academics) and Dr. A. Srinath (Dean-Skill Development) shall also act as resource persons. Dr. V. Venkaiah suggested that the video recordings of the workshop shall be placed in public domain for the benefit of faculty and students.

<u>Agenda Item 1</u>: ATR on the Last IQAC Advisory Committee meeting held on 24-06-2022.

The following resolutions were taken during the last IQAC Advisory Committee meeting held on 24-06-2022:

A. Preparation of various Policies.

The Deans have drafted respective policy documents and submitted for review and approval to the Chairman of BoM.

B. All statutory committees of the University should have one member from IQAC.

Hon'ble Pro VC has accepted this proposal and instructed the Registrar for further steps to be taken in this regard.

C. Preparation of Smart Village Revolution Document and placing it in public domain.

Smart Village Revolution Document is prepared in book format and placed on the SVR webpage.

D. KLEF Annual Report Preparation and placing it in public domain.

Draft KLEF annual report is prepared and is under review. It will be finalized before the next Convocation and will be placed in public domain.

E. Projection of Skill development of the student as distinctive feature. Best practices: (i) Corporate Social responsibilities (CSR), viz. smart village, social outreach programs. (ii) Social work and sports/two skilling courses as mandatory Graduation Requirements.

It has been decided to include the above distinctive feature and best practices (2 No.) in AQAR_2021-22.

Agenda Item 2: Fixing 2022-23 targets to achieve highest marks in NAAC-2023

Dr K. Ramakrishna, Dean-Quality informed the members that Targets have been fixed to all Functionaries to achieve best possible grade in the upcoming NAAC 3rd Cycle of Accreditation.

- Periodic internal Reviews by IQAC Team are being conducted to monitor the progress and to provide necessary guidance.
- Dr. K. Rama, Advisor-NAAC has visited KLEF during 6-7 June 2022 and suggested several measures/steps to be taken for the upcoming NAAC Accreditation. Dr. Rama is requested to visit KLEF once again in the next month to review the progress.
- Few Critical metrics are identified Dean-wise in which honorable Vice-Chancellor is closely monitoring the progress to reaching them.

Dr K. Ramakrishna, Dean-Quality highlighted few critical metrics, viz. % of PhDs among faculty, Demand ratio, % of SC/ST and physically challenged students, No. of PhDs produced by eligible Research supervisors, placing e-content developed by KLEF Faculty in Swayam-NPTEL website, etc.

Dr. V. Venkaiah informed the members that NAAC has been revising the Manual and some of the metrics keep changing. The Revised NAAC Manual May 2021 gives 115 metrics as against the earlier 132 metrics. Weightages of some of these metrics have been changed and KLEF should focus on each nd every metric.

Dr. P. Thrimurthy advised the members that video lectures could be developed in local languages, which may be considered by the Govt websites. He also suggested that KLEF could appoint about 3% additional faculty over and above the norm to ensure 100% marks in Student: Faculty ratio. He also suggested that KLEF could avail itself of the services of Qualified Industry personnel as Co-Research supervisors (for guiding PhD Scholars), Examiners/Evaluators, etc.

Dr K. Ramakrishna, Dean-Quality informed the members that the preparation of NAAC SSR-2023 shall commence on the upcoming Vijaya Dasami day.

Resolution: It is resolved that IQAC shall share the new NAAC targets with the Deans, COE, and the Office of the Registrar within a week. All Deans and functionaries are requested to cooperate in this regard.

Responsible Persons: All Deans, COE, and the Office of the Registrar.

Agenda Item 3: External audit on AQAR-2021-22, SSR-2023.

Dr. V. Venkaiah has suggested that KLEF should establish dedicated Research Centres in the emerging areas of research. This is in line with the recommendations of NEP-2020. KLEF shall also establish a digital repository of all its contents developed by its faculty.

Agenda Item 5: Use of GANTT Charts for planning and monitoring

Dr K. Ramakrishna, Dean-Quality informed the members some of the salient features of GANTT Charts as follows:

- GANTT chart is a monitoring tool. It provides a high-level overview of the tasks they must complete, along with a timetable to finish their work.
- A series of horizontal lines shows the amount of work completed in certain periods of time in relation to the amount planned for those periods.
- · GANTT chart provides a base for remedial plan in case some tasks are found incomplete.
- IQAC recently applied basic version of Gantt chart for monitoring progress of 'Calendar of Activities'. So far, the results are satisfactory.
- Monitoring with 'Centralized Online GANTT Chart' will provide handy updates of progress to all functionaries and authorities.
- This will help to effectively implement strategic targets and to develop remedial / improvement plans in case of deficiency of achievements.

Dr K. Ramakrishna, Dean-Quality has demonstrated the most basic chart developed for IQAC. Both the external members appreciated the efforts of IQAC and encouraged them to move forward in this direction for quick and easy monitoring of various activities.

Resolution: It is resolved to try this on an experimental basis, starting with the IQAC Activities.

Responsible Persons: Dean-Quality.

Agenda Item 6: Status of developing IQAC ERP

Dr. K. Ramakrishna, Dean-Quality has put forth the following requirements regarding the KLEF ERP. IQAC would like the ERP to have the following facilities for making the monthly audits less cumbersome:

- Department IQAC Monthly report generation in ERP.
- Provision for recording IQAC Audit comments by auditors and forwarding to respective functionary.
- Provision for functionary to give compliance.

Resolution: It has been resolved that the Chief Technology Officer should take up this on a priority basis and comply with it within three months' time.

Responsible Persons: Mr. A. Satya Kalyan, Chief Technology Officer, and Dean-Quality.

Agenda Point 7: ATR & Status Report for Strategic Plan & Remedial Plan for next year.

The Dean of Quality presented the Action Taken Report (ATR) and Status Report for the Strategic Plan 2018-23, along with a proposed corrective action plan.

The Dean of Quality reported that Stakeholder Feedback has been collected, analyzed, disseminated to relevant parties, and uploaded on the website for all stakeholders' information.

Agenda Item 9: Quality initiatives in Academics

Dr. K. Ramakrishna, Dean-Quality has suggested the following Initiatives, which fall under Academic Domain:

- For a 3-credit Theory Course, there should be a minimum of 5 Course Outcomes (COs). For
 a 3+1 credit lab-integrated course, there should be a minimum of 5 COs for theory and a
 minimum of 3 COs for the lab component. Additionally, there should be a minimum of 15
 instructional hours per semester for each 1 Theory credit.
- Inviting Expert faculty from premier institutions abroad to teach a few core subjects.

Resolution: It is resolved that the Office of the Dean-Academics shall take up these initiatives from the coming Academic Year_2023-24.

Responsible Persons: Dean-Academics.
