
### Reporting Item 1: NIRF Rankings-2024

### Comparison of NIRF Rankings achieved through 2018 to 2024:



### KLEF NIRF Rankings 2024 Analysis



Comparison of rankings obtained during 2023 and 2024 are depicted below to understand the performane of the Instition in recent times.



The following observations can be made upon Analysis of the rankings:

Steady improvement (2018 to 2024) is visible in the **Overall** category. It improved 10 places between 2023 and 2024. As could be seen, the University rank improved by a phenomenal "6" – from 28 to 22. NIRF Rankings improved by 9 positions in terms of Engineering Category (from 44 to 35). It fell by 27 ranks (from 52 to 79) under the Management category. As a matter of fact, KLEF achieved the best ranking of "38" under Management category during 2021 and the same could not be sustained in the subsequent years!

Both the external members felt extremely satisfied with the KLEF Journey regarding NIRF Rankings, except for the Rank obtained under "Management" category. Both senior Peers felt that a thorough investigation should be made to fathom out the reasons for poor show under "Management" category and corrective action should be initiated. Quality of publications is one parameter, which has a bearing on the rank obtained. They congratulated the IQAC for leading the University to obtain 22nd Rank under University Category.

While continuing to maintain standards which have placed KLEF at such an eminence, it is equally necessary that KLEF must make best efforts to improve NIRF rankings year after year. Keeping these twin objectives in mind, the functionaries (Nine Deans holding different portfolios) have been on a mission to constantly review and improve on the parameters fixed by NIRF.

### Reporting Item 2: Status of NAAC Cycle-3

The Dean (Quality) informed the members the status of NAAC Cycle-3 Accreditation as follows:

- > Institutional Information for Quality Assessment (IIQA) : ACCEPTED
- > Self-Study Report (SSR) as neter, which has a heading on: In SUBMITTED
- Data Validation & Verification (DVV)

The Dean (Quality) also informed the members the University is gearing up for the NAAC Peer Team visit. IQAC is continuously conducting audits of all the Deanships, Departments, centers and various infrastructural facilities and providing comments/feedback. The top management, Hon'ble Vice-Chancellor and the Pro-Vice-chancellors are providing all necessary support to close the gaps and making the University receive the NAAC Peer Team later this year.

To a query from Dr. V. Venkaiah, external member, the Dean-Quality informed that KLEF got a pre-qualification score of 3.78 out of 4.00 for the QnMs.

### Reporting Item 3: Mock audit of KLV & KLH campuses

The Dean (Quality) informed the members that IQAC Team conducted Mock audit of KLEF-Hyderabad campuses at Aziz Nagar and Bowrampet during 16-18 July 2024 in view of the forthcoming NAAC Peer Team visit. The IQAC Team also visited the Global Business School which came up recently at Kondapur. Observations were shared with the respective Principals. IQAC could well visit the Off campuses at Hyderabad one more time before the NAAC Per Team visit.

# Reporting Item 4: Data Quest-Top-T-School in India -2024 & Careers-360-Top Private Engineering Colleges in India-2024

The Dean (Quality) informed the members that KLEF stood eighth among Top Technical Schools (among Government and private sector), third among Private sector and in the southern region in the survey conducted by Data Quest. Career 360 placed KLEF at 25th among the Private Institutions in India and gave AAAA+ Rating among Engineering Institutions. All the members appreciated the efforts of IQAC and the entire KLF family for these achievements.

### Reporting Item 5: University website updation

The Dean (Quality) informed the members that IQAC provided a few suggestions to update the KLEF website. Except one or two, all other suggestions have already been implemented. The remaining changes are expected to be completed later this week.

Both the external experts, Dr. V. Venkaiah and Dr. P. Thrimurthy appreciated the efforts of the entire KLEF Family, particularly the IQAC team, for their dedicated work.

- 4. Audited all the departments (both Engg & Non-Engg) for the upcoming NAAC Peer Team Visit and provided suggestions.

The Dean-Quality thanked the Hon'ble Chancellor, Hon'ble Vice-Chancelor and the Pro-Vice-Chancellors for providing all necessary support in preparing the University for the upcoming NAAC Peer Team visit.

### Agenda Item 3: ISO 21001:2018 Surveillance certification [October 2024]

Dr. K. Ramakrishna, Dean-Quality informed the members that ISO 21001:2018 Surveillance certification is due in October 2024 and will be dealt with appropriately. ISO 21001 is based on ISO 9001 – Quality Management Systems, but it provides a specific framework for educational organizations. It also ensures improved satisfaction of the learners by improving the educational processes and ensuring conformity to learners' requirements.

Dr. K. Ramakrishna, Dean-Quality informed the members that Vigilance Awareness Week (VAW) is being celebrated every year and coincides with the birthday of Sardar Vallabhbhai Patel, known to be a man of high integrity.
