

## **Minutes of Meeting of 52<sup>nd</sup> IQAC Advisory Committee Meeting**

**Held "Online – Webex" on 19.07.2025, from 3:00 pm**

**In the Chair: Dr. G. P. S. Varma, Hon'ble Vice-Chancellor, KLEF**

The 52<sup>nd</sup> Advisory Committee Meeting by Internal Quality Assurance Cell, KLEF was held on 19.07.2025.

Dr. G. P. S. Varma, Hon'ble Vice-Chancellor chaired the meeting. Dr. Varma, in his foreword, welcomed all attendees and appreciated the rigorous efforts put in by the IQAC and all functionaries, in implementing the NEP-2020 in terms of as many points as possible. He also appreciated the efforts of IQAC in obtaining good rankings/ratings by various Accreditation agencies, both National and International. He touched upon the current NBA accreditation work going on in the University. He also indicated that the issues pertaining to Bar Council of India are being taken care of. Lastly the Hon'ble Vice-Chancellor talked about the current buzzword "AI" and how it could be utilized for enhancing KLEF's Research Activities. After this, the Hon'ble Vice Chancellor handed over the proceedings to Dr. K. Ramakrishna, Dean (Quality) to continue further and take up the agenda for the meeting. In response, Dean-Quality pointed out that KLEF is already implementing about 85% of the NEP-2020 recommendations and the balance of 15% of activities shall be taken up soon. The Dean-Quality started the meeting by welcoming the newly appointed Senior Director for P&D division Wing Commander Guru Moorthy Gangadharan and introduced to the advisory committee members.

#### **Reporting Item 1: Status of NIRF Rankings 2025**

The Dean (Quality) informed the members of the present status of the prestigious NIRF-2025 Rankings:

- Data Submission : Completed
- Response to Queries from NIRF : Submitted
- Ranking Results : Awaiting

The Dean (Quality) informed the members that KLEF has responded to the following queries from NIRF during recent months:

1. Sub heads for Capital and operational expenditure
2. Full time PhD Scholars admitted
3. Number of PhD scholars awarded
4. Income & Expenditure statements of Innovation centres
5. Foreign investments & funds received for Start-Ups.
6. Number of students admitted from other states.

He said that NIRF has taken a robust approach this year and is taking stringent measures to avoid criticism from the stakeholders. He hoped that KLEF would find a place in the top 50 Research Institutions besides achieving a good NIRF Ranking this year.

#### **Reporting Item 2: T. H. E. Rankings 2025**

The Dean (Quality) informed the members that KLEF obtained the following T.H.E. Rankings:

- **Asia University Rankings 2025: 301-350**

KLEF stood at 401-500 in Asia University Rankings 2024.

The Dean (Quality) informed the members that KLEF improved their positions in certain SDGs, while they fell slightly in the case of few other SDGs. For nearly 50% of the SDGs, KLEF sustained the same position as last year's. The overall impact ranking remained stationary at 601-800. One of the reasons could be participation by many Institutions this year.

Dr. Thrimurthy congratulated IQAC-KLEF for the achievements in T.H.E. Asia and Impact Rankings (UN SDGs). He suggested to avail the services of distinguished Alumni for the purpose of enhancing the public perception as the weightage for perception has been increased. He felt happy that KLEF is doing well in terms of outreach and inclusivity. The Dean (Quality) informed the members that the T. H. E. is not sending the perception related links to the Alumni, for the present.

The Dean (Quality) also informed the members that the Perception Committee has been reconstituted and met on 11<sup>th</sup> July 2025 or a brainstorming session to find ways and means to enhance perception points which would result in better scores. He also thanked the Hon'ble President and Hon'ble Vice-Chancellor for approving a budget of US\$ 13,760

(Approximately INR 12 Lakh) as annual subscription for joining "Academic Profile" of QS I-GAUGE Rankings from this year. This is one of the measures resolved in the perception enhancement committee meeting.

#### **Agenda Item 4: IQAC Initiatives**

##### **(i). 1-day workshop on Outcome Based Education (OBE)**

**Resolution:** It is resolved to organize a 1-day workshop on Outcome Based Education (OBE) by inviting an external expert. This could be organized during September 2025.

Dr. V. Venkaiah, an external member, expressed his views on this: There is a great possibility that in each department, only a handful of faculties (perhaps 1-2 faculty in some of the departments) could be well-versed with the OBE. NBA visiting experts may ask any faculty a question on the program outcomes/Learning outcomes (graduate outcomes). IQAC may have to do more than conducting the proposed 1-day workshop on OBE. All the faculty of the NBA seeking departments should be able to demonstrate the Institute/Dept's vision, mission and POs. All faculty should know the CO-PO Attainment. Even the students should be aware of the OBE and NBA Process.

##### **(ii). Budget documents of schools/ departments/ Labs, etc.**

As the NBA is very particular about the budget allocations for various programs (Amount sought, amount sanctioned and amount utilized on a year-to-year basis), it is suggested that the Office of the Registrar should assume the responsibility of arranging budget-related documents.

(iii). Covered foot paths connecting hostels to academic blocks and parking areas

The Dean (Quality) proposed that KLEF could cover the foot paths connecting hostels to academic blocks and parking areas, which helps particularly during the rainy season. The P & D said that they will explore the possibility as it involved aesthetics of the campus.

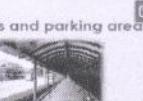

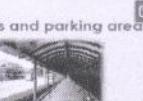
