NOTIFICATION

Whereas, the Central Government is empowered under Section 3 of the University Grants Commission (UGC) Act, 1956 to declare, on the advice of the UGC, an Institution of higher learning as deemed to be University.

2. **And whereas**, in exercise of the powers conferred by Section 3 of the UGC Act, 1956, the Central Government, vide Notification No.9-42/2006-U3(A) dated 20.02.2009, on the advice of UGC, had declared Koneru Lakshmaiah Education Foundation Vijayawada, Andhra Pradesh as an Institution Deemed to be University, provisionally for a period of five years, with certain conditions.

3. **And whereas**, the functioning of Koneru Lakshmaiah Education Foundation Vijayawada, Andhra Pradesh was reviewed by the UGC with the help of its Expert Committee. Based on the advice of UGC, the Central Government, vide Notification No. 9-42/2006-U3(A)Vol.2 dated 11th July, 2017, extended the deemed to be University status of Koneru Lakshmaiah Education Foundation, Vijayawada, Andhra Pradesh from 20.02.2014 to 19.02.2019 with the following conditions:

- i. Koneru Lakshmaiah Education Foundation shall replace the word 'University' with "Deemed to be University" wherever it is being used and make other necessary amendments, whatever required, as per the UGC (Institutions Deemed to be Universities) Regulations, 2016.
- ii. Koneru Lakshmaiah Education Foundation shall rectify all the deficiencies pointed out and suggestions given by the UGC Expert Committee and shall submit compliance report along with documentary proof to UGC within a period of 6 months.
- iii. Koneru Lakshmaiah Education Foundation shall admit students to the approved academic courses / programmes of Koneru Lakshmaiah College of Engineering, under its ambit or any other Courses which are approved by Statutory Council(s) concerned and UGC, wherever required. It shall not admit students in B. Pharm, BFA and BBA-LLB courses and other such courses without approval of the UGC and Statutory Councils concerned.
- iv. The status of Deemed to be University shall be further extended, on the advice of UGC and also after fulfillment of the above conditions.

4. **And further whereas**, in exercise of the powers conferred by section 3 of the UGC Act, 1956, the Central Government, vide Notification No.10-3/2017-U3(A) dated 19th January, 2018, on the advice of the UGC, permitted Koneru Lakshmaiah Education



Foundation, Vijayawada, Andhra Pradesh for starting of an Off-Campus centre at Aziznagar, Moinabod Road, Rangareddy district, Telangana.

5. **Now, therefore**, taking into consideration the compliance report of the Institution and the advice of UGC, the Central Government, in exercise of the powers conferred under Section 3 of the UGC Act, 1956, hereby extends the deemed to be University status of Koneru Lakshmaiah Education Foundation, Vijayawada, Andhra Pradesh from **20.02.2019 to 19.02.2024** with the condition that the Institution shall improve its performance and academic outcomes on the parameters mentioned in the UGC (Institutions Deemed to be Universities) Regulations, 2019.

6. The all other conditions mentioned in the earlier Notification(s) of this Ministry as well as the Rules / Regulations of UGC and other Statutory Councils, issued from time to time, shall continue to be adhered by Koneru Lakshmaiah Education Foundation, Vijayawada, Andhra Pradesh.


