## **Objective**

Legal awareness, also known as legal consciousness, is the empowerment of individuals regarding issues involving the law. About 70% of the people living in rural areas are illiterate and even more than that percentage of the people are not aware of the right conferred upon them by law. We team KLEF-CEA conducting an event named LEGAL AWARENESS at Z. P. High School, on 24<sup>th</sup> February 2023.

## **Description**

The spirit and very purpose of providing free and competent legal services to the weaker and deprived sections of the society, as envisaged in Act, 1987, will be defeated in case the weaker section could not be made aware of their various legal and constitutional rights.

Illiteracy makes a person unable to recognize injustices done to him/her. When a person is ignorant of basic human rights, Social Welfare schemes fail to be effective as he/she is unable to avail of the opportunities provided by the Govt. for upliftment of his/her standard of living.

As such, Legal Literacy is the effective tool to project human rights. It can help the people recognize their civil, political, social and cultural rights. Only when the people can be made aware of what the laws offer to them, they will be less susceptible to injustices confronting them. About 70% of the people living in rural areas are illiterate and even more than that percentage of the people are not aware of the right conferred upon them by law. We team KLEF-CEA conducting an event named LEGAL AWARENESS at Z. P. High School, on 24<sup>th</sup> February 2023.

## **Outcome**

Increase access by providing legal aid. Legal institutions and legal aid offices that provide free legal and low-cost legal advice, training professionals, and legal projects, training and hiring people to act as lawyers and mediators, can all increase public awareness of the legal system. Support legal aid schemes with legal aid schemes used by NGOs. Legal assistants are trained in law and criminal justice to provide legal advice to suspects or alleged suspects in the presence of an informal justice system.

Promoting the recording and resolution of cases improves consensus and provides the basis for a formal referral process.
