The following are the guidelines of Practice School -1 registration for the academic year 2025 -26 to all Engineering Departments and Y22 batch students.

<u>Period</u>: The period of Practice School will be tentatively from July,2025 to October, 2025.

Eligibility: Students having above 6 CGPA, and not exceeding 2 backlogs.

<u>PS Locations</u>: The students are being sent to the Practice School companies located at SIXregions ie., Hyderabad, Vijayawada, Vizag, Bengaluru, Chennai.

<u>Last Date for Registration</u>: The registrations will be closed on 22/03/2025 without any fee. However, late registrations will be allowed with a fee of ₹ 500/- upto 29/03/2025.

<u>Cancellation of Registrations</u>: Usually the students registered for Practice School shall not be permitted to withdraw or cancel their registration. However, in deserving cases the cancellations will be allowed with a cancellation fee of ₹ 2,500/- along with a letter explaining the reasons for cancellation.

Evaluation components: Practice School program is evaluated for a maximum of **100** marks. The aggregate marks awarded to each student shall subsequently be converted into grades as per the University regulations. Various components of evaluation and weightages are:

Important Guidelines:

- i) Practice School program carries 6 credits. Therefore, it involves substantial effort and requires seriousness, commitment and dedication from the students. One has to hard work for good experience and better placement opportunities.
 - Students must be disciplined, hard working and possess good attitude to undergo On the Job Engineering Training (OJET).
 - iii) Students must abide by the rules and regulations of the company and the University fallowed dress code in the company.
 - iv) Practice School is not mandatory for the students. However, Practice School experience enhances the opportunities for placement.
 - v) Some Practice School companies do the selection of students for Practice School program. In such cases, the notices will be sent to the Departments, PS-Notice Board, PS-Website & SMS regarding schedule of selections as and when a company is visiting the campus. Interested students shall attend the selection process for the companies.
 - vi) The students, who were not selected by the companies in the campus, will be allotted a company by the Director, Practice School. Allotment of company is done basing on the CGPA of the students and the availability of vacancies in the companies of their relevant branch of engineering.

- vii) Students who have submitted the Registration-cum-Data Form will not guarantee the Practice School. The number of students sent to the Practice School purely depends on the number of permissions obtained in various companies for different branches of engineering.
- viii) At the time of allotment of companies, the students should be ready for opting companies in any of the location (Hyderabad, Vijayawada, Vizag, Bengaluru, Chennai) depending on the availability of the vacancies in their respective branches.
- ix) ONCE THE STUDENTS ARE SELECTED BY A COMPANY OR ALLOTTED TO A COMPANY SHALL NOT BE ALLOWED EITHER TO CHANGE THE COMPANY OR TO CANCEL FROM THE PRACTICE SCHOOL.
- x) The decision of the Director, Practice School is final and binding on all the students.
