The Dean, Quality presented the Dean's office audit reports to the committee. The Dean, Quality reported that the following Dean's offices were audited by IQAC.

The Dean, Quality also reported that the Dean, P&D office audit is in progress. The audit observations, recommendations / suggestions presented by Dean, Quality are as follows:

Dean, Academics

Audit observations:

- 1204 courses identified having focused on employability/ entrepreneurship/ skill development offered by the University.
- **198** new courses are introduced.
- **63** programs identified under Choice Based Credit System (CBCS)/ Elective course system.
- **137** courses identified under value-added courses for imparting transferable and life skills.
- 20606 students enrolled and course wise count is also available.
- **9555** students undertaking field projects / research projects / internships and the count is improved.
- **100%** of teachers using ICT for effective teaching at present Learning Management Systems, E-learning resources etc.
- Mentor-Mentee Ratio is 1:12.
- E-Content developed in LMS by all the faculties.

Dean, Student Affairs

Audit Observations

- Details of Extension activities conducted in the neighbourhood community are available.
- Verified the no of awards and recognitions received for extension activities.
- Transparent mechanism is implemented for timely redressal of student grievances including sexual harassment and ragging cases through ERP.
- Verified the sports / cultural activities/ competitions organized at the institution level.
- Verified the details of programs organized under Gender equity promotion.
- Verified the Activities planned and organized to increase consciousness about national identities and symbols; Fundamental Duties and Rights of Indian citizens and other constitutional obligations.

Recommendations / Suggestions

- Recommended to maintain the list of participants of Extension activities, Outreach programs.
- Recommended not to show Hobby club activities as Extension activities.
- Recommended to conduct events for Sensitizing students to social issues and towards holistic development.
- Recommended to have proofs for Online events conducted and they shall reflect the date, time and no. of participants.

Discussion on Agenda item 1:

Dr. S. Venkateswarly, Dean – Progression and Training reported to the committee to note that the placements are 100% with an average package of 5.2 Lakhs per annum. The total number of students appeared for national and international competitive examinations are 824. The committee found the above submission is a good improvement and appreciated.

Agenda Point 2: Central level facilities audit report

The Dean, Quality submitted the central facilities audit report to the committee with the audit observations and recommendations for improving the quality parameters. The Dean, Quality stated that the audit of hostels, canteen, health cares, transport, central instrumentation facilities, hardware & networking facilities were completed.

The following are the audit observations and suggestions submitted by IQAC.

Hostels

Audit Observations

- Well maintained kitchen and hostel rooms with good hygiene.
- Well balanced diet, based on the feedback menu will be changed according to the need of students.
- Different food menu is maintained for Indian students and international students.
- Round the clock Security, CC Camera coverage and Fire Safety arrangements.
- Doctor/Medical facility, & Emergency ambulance service available.
- Psychologist is available for regular counseling.
- Covid-19 precautions are maintained with limited number of students per room.
- Social distance is maintained in Kitchen.
- Providing time for hobby clubs and other activities.
- Special coaching facility is available for hostel students who are having backlogs.

Suggestions/Recommendations

- Library Facility is available up to 5PM only, advised to Extend it up to 9PM.
- Recommended to extended computer centers/labs facilities made available after
 5.00 pm.
- Suggested to conduct study hours for non-engineering students also.
- Recommended to provide separate Electricity meters for each room.
- Recommended to maintain proper record of cleaning activity.
- Recommended operable separate Gym facility for both boys and girl students.
- Recommended to maintain Social Distance in the mess with 3 members per dining table.

Canteen

Audit Observations

- Price lists of all items in the canteens are available as per the 2019-20 approved list.
- US Pizza center: Good in maintaining hygiene and well cleaning procedure.
- Satish Canteen: Valid FSSAI certificate is available.
- US Pizza : Valid FSSAI certificate is available.

Suggestions/Recommendations

- Agreement copy is not available with the canteens.
- The cleaning in main canteen is not satisfactory.
- Valid FSSAI certificate is required for main canteen.
- In Sateesh canteen food items are to be kept in a closed display units to avoid dusting.
- Food court at boys Hostel is not having approved price list.

Health center

Audit Observations

- All 4 centers are well maintained.
- 3 Doctors (ONE full time, TWO part time) & 3 Nurses (Full time) are available
- Free medication is provided.
- Instant approval for purchase of medicines is in practice.
- Facilitiesbeing provided in health center are found satisfactory.

Suggestions/Recommendations

Health center organogram is to be prepared.

Suggestions from Physicians:

- See that Glucose-D is available in every department.
- Patients (Student or Staff) should be brought to Dispensary rather calling the physician to the department.
- Message to Parents "Don't send your wards to college without feeding breakfast".

Transport Department

Audit Observations

- Out of 86 only 25 buses are in use, due to partial closure of University & Work from home faculty extended to faculty.
- Sanitization of buses is taking place regularly. All buses are having First aid kits.
- Driving Licenses of all drivers are verified and found in order.
- Meeting with drivers, supervisors are being held regularly.
- Vehicle permit, insurance, taxation, fitness and pollution check are updated regularly.
- Fuel, oil, servicing bills and utilization details are recorded and approved by Vice president regularly.

Suggestions/Recommendations

- Recommended to conduct financial audit which was not happened from 2020.
- GPS tracking system is recommended for all buses.

Central Instrumentation Facility

Audit Observations

The Dean, Quality stated that, during the audit it is observed that the following instruments are available and are in working condition.

- Suggested that efforts shall be made to generate revenue from this centre.
- Suggested that Log Book shall be maintained for the equipment utilization.

Hardware & Networking

Audit Observations

- Work/ repairs orders: Tickets are raised by the departments through ERP and it was solved within 7days and is updated in ERP.
- List of equipment (Soft copy) department wise is available.
- List of operating/ maintenance personnel (Soft copy) is available.
- Maintenance policy document (Soft copy) is available.
- List of new purchases & their bills/invoices are available.

Suggestions/Recommendations

- Suggested to update the list of software's available in the University frequently.
- Suggested to dispose the scrap/ unused electronic waste to authorized vendor.
- Recommended to maintain the record of Condemned or not working computers/ other equipment.
