- Reports shall be generated at the click of a button.

The Dean-Quality has explained in detail the possible benefits from this Initiative.

Dr. A. Srinath, Dean (SD & SP), who is presently monitoring the ERP assured the members that the above facilities shall be made available with ERP before the end of April 2025.

## **Agenda Item 4: IQAC Initiatives**

**Resolution:** Prof. Hari Kiran Vege, Additional Dean (Academics) responded to this suggestion and said he will discuss with Board of Studies of different departments and come out with a suitable decision.

**ii.** As per the statutory requirements of AICTE, it is recommended that 2/3 of the Engineering Departments and the MBA Department shall go for NBA accreditation.

Resolution: Dr. G. P. S. Varma, Hon'ble Vice-Chancellor, KLEF approved this proposal.

- iii. The Dean-Academics shall be advised to
- a. Organize PO assessment based on the revised POs prescribed by the NBA and
- **b.** Establish a procedure for gathering information on PEOs from alumni, as required by the new NBA norms.

The Dean-Quality has added that KLEF could go for NBA Accreditation up to SIX Departments in place of the earlier decided BT, ECE & CSE Departments.

#### **Resolutions:**

Prof. Hari Kiran Vege, Additional Dean (Academics) informed the members that

- The Dean-Academics has already taken up the task of revising the Vision-Mission statements of different departments.
- the faculty shall be trained on the new POs and
- the Alumni Cell shall collect the necessary information on PEOs as per new NBA
   Norms from the coming Academic year.

## Agenda Item 5: Any other item

- 1. Under this, the Dean-Quality briefly explained the Attributes of the proposed highlevel structure (latest NAAC Accreditation system).
- 2. Professor P. Thrimurthy discussed the following aspects:
  - a. First, he enquired about the constitution of IQAC Advisory Committee, which was explained by the Dean-Quality.
  - b. He then suggested IQAC to identify other reputed Accreditation bodies other than NAAC, both National and international. He emphasized the

importance of NBA/ABET accreditations. He also recalled his suggestion to go for NAAC during 2008.

c. He said that KLEF shall challenge itself in reaching higher goals and archive the same.

The Dean-Quality assured the members that, as always, IQAC continues to be the torchbearer of quality and move forward in elevating the status/reputation of KLEF.

The meeting was adjourned with the Registrar thanking the members for their cooperation.
