


**Q. HOW DID YOU MANAGE STUDIES

I would wake up at 3 AM every day. Mondays and Tuesdays were for my boxing practice. Wednesdays and Thursdays were dedicated to dance practice. Fridays and Saturdays were for music practice. And finally, Sunday was my rest day.

**Q. WHAT WAS YOUR GREATEST
CHALLENGE THROUGHOUT
YOUR JOURNEY AND DID YOU
OVERCOME IT?**

Being a South Indian, I was accustomed to a diet primarily consisting of rice. This transition to a different cuisine posed a significant challenge for me. Initially, I found it difficult to adjust my food intake to meet the demands of my training. Additionally, the limited availability of healthy meals in the hostel presented an obstacle in adhering to a balanced diet. Moreover, the lack of support from certain individuals, who suggested I abandon this sport due to the frequent injuries I sustained, further complicated my journey. However, my father's unwavering encouragement served as a pillar of strength, while my mother's concern for my well-being reflected her deep-rooted love."
