K L E F is also providing fee concession amounting to Rs. 10,000/- per year. K L E F had provided this fee concession to 747 SC/ST students during the last academic year 2021-2022.

As in the previous years, every Minority student should benefit from this policy of the management. As a matter of fact this fee concession is being provided to all Minority students at the time of fee payment, which takes place at the beginning of each semester. This year nearly 70% students got placements and 30% students went to higher studies.

Dr. Ch. Hanumantha Rao, Chairman Minority Cell has advocated to the members to bring forward any issue relating to any Minority student not receiving the fee concession for possible resolution.
