The work relating to the implementation of the reservation policy may be monitored by the above stated Committee. The validity of the committee is 2 years.
- 3. Any grievance submitted by OBC students must be resolved within 15 days upon receipt of the grievance.
- 4. Students are selected to serve on the OBC committee according to their academic excellence and adherence to ethical standards. The names of students are recommended by the respective Heads of Departments, and the composition of the committee is ultimately determined by the Dean of Student Affairs, subject to approval by the Vice Chancellor.
- 5. As per the OBC policy, maximum amount of Rs. 5,000/- will be sanctioned as scholarship for eligible candidates.
- **6.** As per the admission policy of KONERU LAKSHMAIAH EDUCATION FOUNDATION 22% reservation is given for OBC candidates.
- 7. Depending on the nature of grievance received the committee must resolve the grievance within 3 days to 15 days.
