- 4) The citation should be given to the early researchers while using connected data in our reports to avoid plagiarism issues.
- 5) The ethical principles specified by professional societies like the institution engineers IEEE, ASME, ASCE, AICTE, and UGC scrupulous only follow.

The chairman and convener thanked all the members for giving their valuable suggestions to the researchers through the formulation of research ethical norms.
