#### **OBJECTIVES**

The objectives of organizing a two-day webinar on "Cyber Threats, Safety, and Security for Girls Students" are to empower female students with crucial knowledge and skills to navigate the digital landscape safely, including recognizing and mitigating gender-specific cyber threats like online harassment and privacy breaches; fostering a sense of digital self-confidence and promoting cyber security as a career option; equipping participants with practical strategies for maintaining online privacy, using social media securely, and handling cyber bullying; encouraging open dialogue and awareness surrounding online safety issues; and creating a supportive online community where girls feel confident, informed, and capable of safeguarding their digital identities and well-being..

#### **DESCRIPTION**

KLEF Women's Forum in association with KL College of Law, conducted Two-day webinar on 30<sup>th</sup> & 31<sup>st</sup> August, 2020 on "CYBERTHREATS, SAFETY AND SECURITY MEASURES". Resource person Ms. T. Vijayalakshmi, Psychologist, KLH and Dr. K. I. Pavan Kumar, HOD, KL College of Law have enlightened the participants. This event started with a welcome note by the convener of KLEF Women's Forum Dr. S. V. N. L. Lalitha. She explained about the Women's forum activities. Dr. K. R. S. **Technical Precautions:**

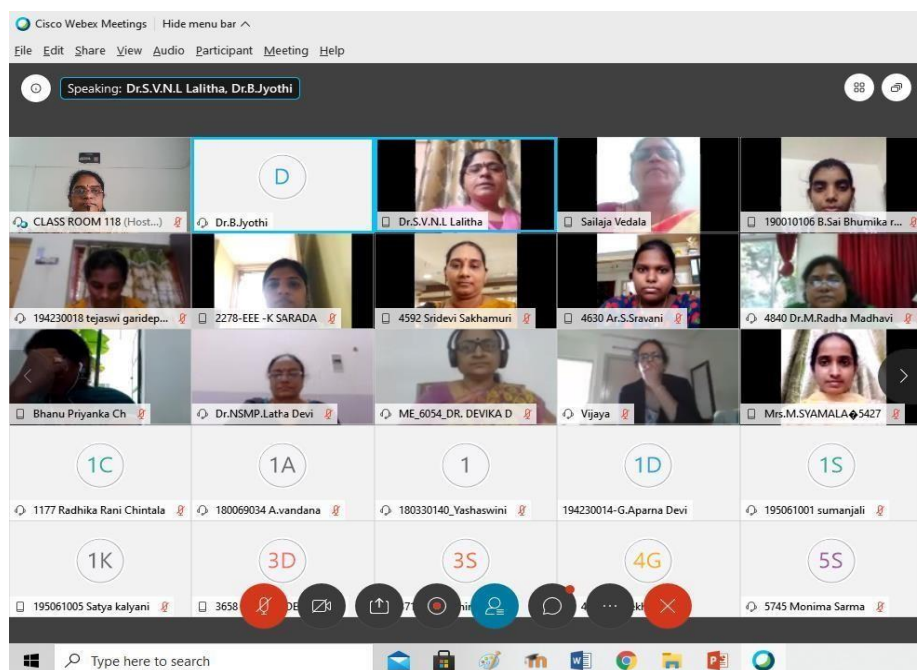
- 1) do not reveal your IP address : online intermediary payment portals do need your IP address to process your payment.

**Social Precautions:**

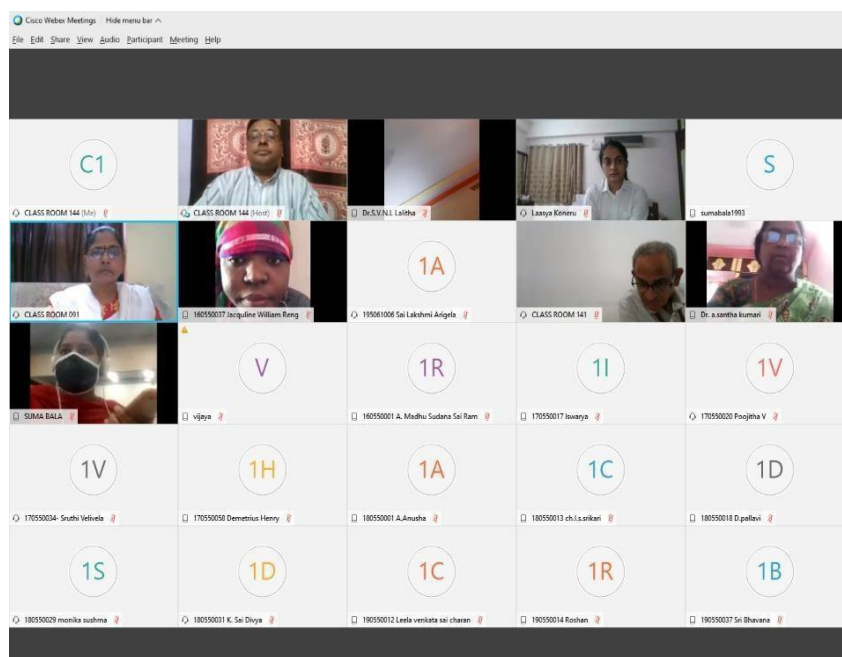
- 1) keep low profile
